The Wayne County Probate Court will be closed in observance of Thanksgiving on Thursday, Nov. 26, and Friday, Nov. 27 and will reopen on Monday, Nov. 30 at 8 a.m.

Lawyer edits, co-writes handbook on dispute resolution clauses

The 229-page compendium includes individual chapters on the relevant law in the following jurisdictions: Albania, Argentina, Australia, Austria, Belarus, Belgium, Brazil, Bulgaria, Canada, China, Croatia, Cyprus, Czech Republic, Denmark, England, Estonia, Finland, France, Guatemala, Hungary, India, Ireland, Italy, Japan, Latvia, Lithuania, Macedonia, Malaysia, Mexico, Moldavia, Montenegro, Netherlands, Norway, Philippines, Poland, Romania, Russia, Serbia, Singapore, Slovakia, Slovenia, South Africa, South Korea, Spain, Sweden, Switzerland, Turkey, UAE, Ukraine, New York, and the USA.

In addition to co-editing the compendium, Acomb co-authored the United States chapter. He also serves as an Officer of the International Bar Association Litigation Committee, which published the handbook online.

Miller Canfield's International Disputes Group, which is led by Acomb, has a robust transnational litigation practice and has presented and defended a wide range of international arbitration claims, conducted under most institutional rules, in every major region of the world.
